The ABA is a professional accounting credential that demonstrates that the credential holder has a thorough knowledge and proficiency in financial accounting, financial reporting, financial statement preparation, taxation, managerial accounting, business law, and ethics for small- to medium-sized businesses. Accredited Business Accountant is the designation for Accreditation in Accountancy. In states where use of this designation is not permitted, individuals use Accredited Business Advisor.

The ABA is accredited by the National Commission for Certifying Agencies (NCCA), an independent resource recognized as the authority on accreditation standards for professional certification organizations and programs.

The ATA is a leading national credential for tax practitioners who demonstrate a thorough knowledge of the existing tax code and the preparation of tax returns with an expertise in comprehensive 1040 issues including supporting schedules, self-employed returns, and ethics. The exam tests for sophisticated tax planning issues, including planning for owners of closely held businesses, planning for the highly compensated, choosing qualified retirement plans and performing estate tax planning.

The ATP is also a leading national credential for tax practitioners who have a thorough knowledge of the existing tax code and the preparation of individual tax returns with an expertise in comprehensive 1040 issues including supporting schedules, self-employed returns, and ethics.

The next testing window for the ACAT exams, including the ABA, ATA, ATP, and the Accredited Retirement Advisor (ARA) credentials, is November 23 – December 16, 2013.

The ARA credential recognizes professionals who have a thorough knowledge of topics relevant to retirement planning and special issues of senior citizens.
