Their expertise covers tax returns for individuals, business entities, fiduciaries, trusts and estates, as well as tax planning, tax consulting and ethics.
- Accredited Tax Preparer® (ATP) For practitioners who have a thorough knowledge of the existing tax code and the preparation of individual tax returns. Their expertise covers comprehensive 1040 issues (including supporting schedules, self-employed returns, etc.) and ethics.
- Accredited Retirement Advisor® (ARA) For practitioners who have expertise in preparing their clients for retirement; the essentials of estate and trust planning and choosing appropriate retirement plans.

Tax and accounting professionals earn their credentials through a combination of experience and passing a credentialing exam.

Carla Rich of Pensacola, FL was also elected as ACAT Vice President/Educator. She was previously an ACAT Board member.

Two new ACAT Board members were also installed at the NSA Annual Meeting, including:
